<p><i>Evidencing and depositing of authors work/subject of related rights is aimed for the purpose of providing an evidence of the existence of the work in cases of violation or unauthorized use of the work.</i></p> <p><i>Authors works and subjects of related rights are deposited with the Agency for the period of 5 years.</i></p> <p><i>Upon expiration of 5 years from the date of depositing, holders of copyrights and related rights are obliged to renew depositing for next 5 years, or to withdraw their works from the Agency's archive.</i></p> <p><i>Upon expiration of one year from the date when holders of copyrights and related rights were obliged to renew the depositing or to withdraw their works from the Agency's archive, Agency will have the right to forward the works in question to third interesting parties, such as Associations of authors, Institutions for science and art or Archives for further proceedings.</i></p>	<p><i>JAA-Serbian authors agency is dealing with realization of copyrights and other intellectual property rights, which includes gathering and processing authors and rights holders data, forming, updating and saving data bases needed for realization of intellectual property rights.
